

## Release of Examination-related Materials :

### Admission Form

Admission Form is applicable to candidates who enrolled for the **paper-based examination (PBE)**, it will normally be accessible for candidates download and print via the HKSI Institute Online Portal on the following days. On the examination date, each candidate must bring the hard copy of Admission Form and his/her original and valid (non-expired) identification document and report to the examination centre at least 15 minutes prior to the scheduled starting time of the examination.
