

Release of Examination-related Materials :

Admission Form

Admission Form is applicable to candidates who enrolled for the **paper-based examination (PBE)**, it will normally be accessible for candidates download and print via the HKSI Institute Online Portal **THREE working days before the respective examination**. On the examination date, each candidate must bring the hard copy of Admission Form and his/her original and valid (non-expired) identification document and report to the examination centre prior to the scheduled starting time of the examination.

(Note : For the candidates enrolled in the compute-based examination (CBE), on the examination date, each candidate must bring his/her original and valid (non-expired) identification document and report to the examination centre at least 30 minutes prior to the scheduled starting time of the examination.)
