Personal Information Collection Statement

- 1. The Personal Information Collection Statement ("**PICS**") is made in accordance with the guidelines issued by the Office of the Privacy Commissioner for Personal Data. The PICS sets out the policies and practices of the HKSI Institute with regard to your personal data¹ and what you are agreeing to with respect to the HKSI Institute's use of your personal data for the purposes identified below.
- 2. Data collected may be accessible by the HKSI Institute's officers, persons or committees processing membership application and related matters. Please refer to the HKSI Institute's privacy policy on its website at https://www.hksi.org/en/privacy-policy/.

Purpose of Collection

- 3. The personal data provided in the membership application form will be used by the HKSI Institute for one or more of the following purposes:
 - evaluating and processing of your membership application and the making of other membershiprelated decisions;
 - contacting bodies relevant to your application to check and verify the information submitted in your application;
 - research and/or statistical purposes;
 - any other purposes directly relating to any of the above.

Transfer of Personal Data

- 4. The HKSI Institute will keep your personal data confidential. However, subject to the provisions of any applicable law, the personal data may be:
 - supplied to any agent, contractor or third party who provides administrative or other services to the HKSI Institute, local and overseas and who has a duty of confidentiality to us, including such persons as external auditors, consultants and agents;
 - disclosed to any governmental or regulatory authorities or departments, or courts of law or any other
 person, in Hong Kong or elsewhere, for the purpose of verifying personal data provided by you to the
 HKSI Institute.

Access to Data

- 5. Unless otherwise agreed, any documents containing your personal data that you provide to the HKSI Institute will become the property of the HKSI Institute and will not be returned to you. The HKSI Institute will destroy any documents and personal data it holds in accordance with its internal policy and applicable laws. Applicants are required to complete their applications within three months. Failing that they may be deemed to have withdrawn their applications. Personal data of the unsuccessful and withdrawn applicants will be destroyed within three months from the date of rejection or withdrawal.
- 6. You have the right to request access to and correction of your personal data in accordance with sections 18 and 22 and Principle 6 of Schedule 1 of the Personal Data (Privacy) Ordinance (Chapter 486 of the Laws of Hong Kong). The HKSI Institute has the right to charge a reasonable fee for processing of any data access request.
- 7. 收集個人資料聲明

- 1. 個人資料收集聲明(`聲明')是根據香港個人資料私隱專員公署發布的指引制定·聲明列出香港證券及投資學會(`學會')對您的個人資料² 政策和作業守則·以及您同意學會將您的個人資料用作下列用途。

收集資料目的

- 您於會籍申請所提供的個人資料,將被學會用作以下列一項或多項用途:
