#### **Cash and other Rewards**

Shortlisted individuals/teams will be rewarded with prizes such as cash, eCredits, internship opportunities (if applicable), meeting with senior executives or ESG experts.



## Complimentary Student Membership or eCredits for Member Ambassador

Non-Student Members will be offered **one-year complimentary membership**, while our existing Student Members who refer friends to join Student Membership and participate in the competition will receive eCredits.



## **Engagement with Senior Executives**

Participating students will be **coached by senior executives and experts** from financial institutions and gain valuable opportunity to explore the **ESG** field.




