- b. Professional qualification holder of Certified International Wealth Manager (CIWM): or Certified International Investment Analyst (CIIA); or Certified Private Wealth Professional (CPWP); or Certified Trust Practitioner (CTP) AND
- c. Holds or has held a senior / executive position with at least 10 years of relevant industry experience as listed in Annex 2.

3. Contribution Route

- a. At least 2 years of Ordinary Membership; AND
- b. Holds or has held a senior / executive position with at least 10 years of relevant industry experience as listed in Annex 2; AND

- 4. The HKSI Institute will keep your personal data confidential. However, subject to the provisions of any applicable law, the personal data may be:

Access to Data
