Sustainability Disclosures

Use of scenario analysis to assess exposure to climate risks and explore adaptation and mitigation measures to address climate risks.



Net Zero

Understand emissions across operations and value chain and to advance on net zero and decarbonisation.

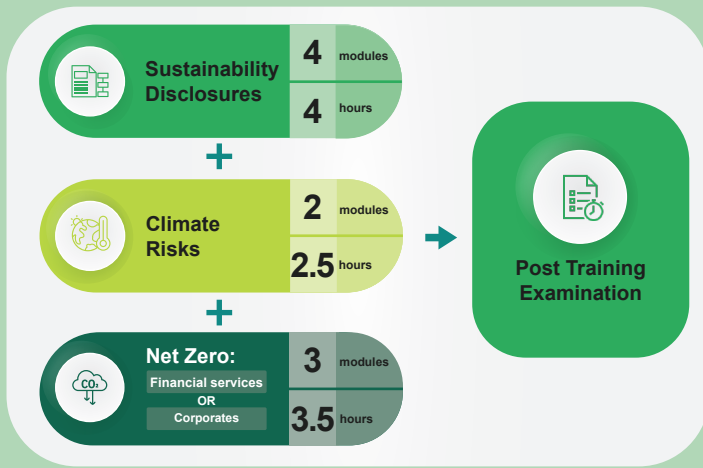
